Dear Lesley

While your office is still working through the concerns raised, we would like to bring to your attention the OIA request response we received on Friday, 28 February.

As you know, we made 4 Teaching Council complaints against our son's past teacher Victoria McDonald, in April 2023. Then 17 months later, after the Royal Commission into Abuse released it's final report Whanaketia, we were advised by the Teaching Council in a letter, it had decided to take "*no further action*".

The Teaching Council advised the *no further action* decision was made after it reviewed documentation it received – *"including a response from the teacher."*

That letter stated – "the complaint, along with this letter, will be confidentially held on our internal files."

In regard to the OIA request made, for the date Victoria McDonald was notified of the Teaching Council decision, Deputy Chief Executive, Clive Jones replied – *"The Teaching Council was unable to make contact with Victoria McDonald during this process as it was unable to obtain current contact address details."*

He also wrote - "The complaint remains on her file."

You advised us in your letter dated 19 December 2024, you and your team have talked about and carefully considered the situation. Not only did your office fabricate investigation of individual teachers by the Ombudsman, it has also fabricated *a response from the teacher* - which is deceptive and dishonest.

The Teaching Council tricked us into thinking it had contacted the teacher, provided her with our complaints and evidence, received a response from the teacher and that that response had contributed to the decision, *to take no further action on this matter*. This would have been our understanding still, if not for the OIA response we received on Friday. This is totally unacceptable.

If your office had contacted us during the 17 months that it held the Victoria McDonald complaints, we could have advised Victoria McDonald was originally from where her family still lives, and have lived for generations. Her parents, have their contact details online.

Thank you for your letter dated 30 January 2024 requesting information as follows:

Please provide the date that each of the 5 teachers (Mary Erin Cairns, Hera Fisher, Victoria McDonald, Kay Schimanski, Paul Anderson-Kereti) were first notified (in writing, verbally or otherwise) of the Teaching Council decisions, in relation the Teaching Council complaints we made against them.

We have considered your request under the Official Information Act 1982 (OIA) and can advise you as follows.

Mary Erin Cairns, Hera Fisher, Kay Schimanski and Paul Anderson-Kereti were first informed of the Triage Committee's decision via phone call on 19 September 2024. They were each sent a letter confirming this outcome on 20 September 2024.

The Teaching Council was unable to make contact with Victoria McDonald during this process as it was unable to obtain current contact details. The complaint remains on her file, noting she has not held a practising certificate since 2017.

We are still working through the concerns raised in your letter and will respond to you in full as soon as we are able to.
